

Much-Needed Pro-Life Law Protects Unborn Babies Created by In-Vitro Fertilization

This month, Arizona passed a one-page bill titled SB 1393i, a unique piece of legislation that recognizes the right to life for human embryos created by in vitro

fertilization, whose parents are in the process of divorcing. This is important, most obviously, because there is very little legal protection or regulation on assisted reproductive technology. This law will protect human embryos, in limbo during a divorce procedure, from being destroyed. However, the law can also bring about interesting legal



conversations—if a law is in place to protect human embryos from being destroyed, how will that impact how people think of the rights of unborn children in the womb? Read more.

#### The Loneliness Trap

Despite technology and social media making communication easier and faster than ever before, a sad reality is immerging. Young people are lonely. Using an industry standard loneliness scale, researchers with the health service company Cigna surveyed more than 20,000 American adults about their subjective feelings of loneliness and social isolation. Adults in Generation Z (ages 18 to 22) scored 48.3 overall, with millennials (ages 23 to 37) at 45.3, Generation Xers (ages 38 to 51) at 45.1, and baby boomers (ages 52 to 71) at 42.4. Adults age 72 and older ranked the least lonely with a score of 38.6. While this is distressing enough, what is worrying sociologists and psychologists is that there is a contributing factor in these groups of lonely people that is also increasing—pornography use. #### Advocates against Assisted Suicide Show That Love Endures and Gives Life

James Joseph "J.J." Hanson was a young husband, father, Marine, and Iraq war veteran whose world was upended when he was diagnosed with terminal brain



cancer. His diagnosis came at a time when *People* magazine was celebrating Brittany Maynard's decision to end her life and euthanasia proponents were pushing to legalize assisted suicide. Instead of

succumbing to despair, however, J.J. lived three years beyond his doctor's prediction, and he and his wife Kristen had a second son. He even spoke via video at AFL's first Summit: Mobilizing the Church for Life in January 2016. Months after J.J.'s death, Kristen testified in Albany, NY, against assisted suicide, bringing with her a message we mustn't forget: love gives people hope. Read more

#### **Euthanasia Hurts Palliative Care in Quebec**

When is choice not a choice? When there is only one option. Sadly, such is the case with palliative care in countries, such as Canada and the Netherlands, in which euthanasia is legal. Dr. Charles Bernard, the head of the provincial medical association in Quebec and a euthanasia supporter, stated that some patients were forced to choose to be killed because they couldn't access quality palliative care. Worse, the College des Medicins has been receiving reports from doctors about the re-direction of needed resources from palliative care to medical aid in dying. Read more.
